ORDER

As per letter read above, Chief Engineer (R&B) has submitted estimate amounting to Rs. 3900.50 lakhs for urgent maintenance works for Sabarimala roads under PWD, in connection with the Sabarimala Festival for 2010-11.

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the maintenance and repairs of Sabarimala roads for a total amount of Rs. 1344 lakhs in connection with sabarimala Festival 2010-11 as detailed below:

3. The Chief Engineer (R&B) will ensure that the renewal programme works are carried out after the monsoon is over ie. by September/October 2010.

4. The amount will be spent for works strictly in the following order of priority:-

- I. Sabarimala Roads (Identified by Hon. High Court and Commissioner).
- II. Traffic safety for the above roads.
- III. Connected roads.

Thermoplastic paint will be done only over newly laid surfaces. Enamel paint will be applied over existing roads included in the patch works.
