The Final Seniority List of 1st Overseer for the period from 1/4/1990 to 31/12/2005 was published read as 2nd paper above. In the Seniority lists, the incumbents, those who are appointed under Compassionate Employment Scheme was fixed w.e.f the date of Government Order. As per read as 1st paper above, the seniority of the 1st Grade Overseer posted under Compassionate Employment Scheme have to be fixed w.e.f the date of posting order issued by the appointing authority. Some of the 1st Grade Overseers have submitted representation and alleged the discrepancy of seniority assigned to the incumbents under Compassionate Employment Scheme.

Considering the representation and in accordance with the Government Order read as 1st paper above, the Seniority of the 1st Grade Overseers, those who are appointed under compassionate Employment Scheme and included in the final Seniority List of 1st Grade Overseers were provisionally re-assigned w.e.f. the date of posting order and issued Orders read as 3rd paper above by this office. The Order was published through the official web site. Necessary time had been given to the aggrieved persons, with the provisional re-assignment, to file their objections / petitions before the undersigned with in the stipulated time. The received petition have been examined in detail after the stipulated time and modifications are effected wherever necessary and the list prepared with this proceedings.
