

CIRCULAR

Sub:- Estt-PWD-Transfer and Postings of 3rd Grade Overseer-Implementation of orders – instructions – Reg.

Ref:- This office proceedings of even No. dtd. 05/06/2010 and 10/06/2010

It has come to notice that certain of the Subordinate Officers mostly on the part of Section Officers are expressing disregard on the General Transfer orders and raising proposals against the transfer orders, issued on public interest, demanding to retain some of the incumbents under orders of transfer instead of complying the orders. In most of such proposals received through proper channel, it is found that the officers themselves act with the intention of fulfillment of certain interests. This is clear violation of rules and insubordination. The objective of the general transfer is also being challenged in a way or other, warranting disciplinary action. Instances were also noticed that relieving of the incumbents who are under orders of transfer is also deliberately delayed even after repeated directions from the undersigned. It should be taken care that there exists all shelter under rules to every incumbent if they are aggrieved with the said transfer if any, to get redressed their grievances which should be submitted to the office of the undersigned through proper channel along with due recommendation. Such reasonable requests made by the incumbent himself and not received through proper channel will not be entertained in any circumstances. Hence, the practice of making proposals against transfer orders by the heads of sub offices is to be curtailed with immediate effect. The circular instructions and directions issued in this regard from time to time should also be scrupulously followed, and the order under reference cited should be implemented in due course.

The kind of actions/proposals if any made from any level of subordinate offices in future on vested interest will be viewed very seriously and disciplinary action will be initiated without notice. Every immediate Controlling Officer on receipt of such proposals against the orders issued if any, should report the names and designation of such officers forthwith to proceed with disciplinary actions. All Superintending Engineers and Executive Engineers should take immediate action to bring the contents of this circular to the notice of all concerned and acknowledge the receipt of the circular with in a fortnight positively, failing which further action will be initiated Suo moto.

All Executive Engineers/Assistant Executive Engineers should submit a list of incumbents those who are already under orders of transfer but not relieved so far, if any, along with the name/details of the head of office immediately on receipt of this circular.

This circular is also applicable in all cases of Transfer and posting ordered from this Office as well as that will be in future.
