## **CIRCULAR**

Sub:- Public Works Department - Submission of proposals for consideration of SLEC / SLMC meeting - Instructions - reg.

As the file of SLEC/SLMC meeting is processed electronically, it causes lot of difficulty to present the facts before the committee. Hence it has been decided to process the file of 'G' Section dealing with SLEC / SLMC meeting physically also. For proper consolidation of details regarding SLEC / SLMC proposals, the following instructions are hereby issued for strict compliance by all concerned.

- 1. The proposals / files that are recommended and forwarded to Revenue Department and those appear in the agenda of the meeting should be made available to the consolidation section in physical / printed form.
- 2. The print out should accompany with a checklist which includes the following details:
  - (i) Copy of the Administrative Sanction issued for the work.
  - (ii) Copy of the Administrative Sanction issued for the Land Acquisition
  - (iii) Amount for which Administrative Sanction was accorded for the work and for Land Acquisition separately.
  - (iv) Extent of land to be acquired.
  - (v) Number of families to be rehabilitated.
  - (vi) Length of proposed road with chainage.

3. The concerned Sections in Public Works Department should brief the details of proposals to the Principal Secretary at least one day before the meeting. The Chief Engineer / Chief Executive Officer / Managing Director concerned should brief the Principal Secretary with video clippings at least one day before the meeting.
