As per the reference 2nd cited, the Assistant Executive Engineer, PWD Electrical Sub Division, Kerala Legislature Complex, Thiruvananthapuram has forwarded an estimate amounting to Rs. 46,000/- (Rupees Fourty Six Thousand only) for providing 1 no 1.5TR High Wall three star rated split type A/C unit with 4 KVA voltage stabilizer and connected items etc in the bed room (upstairs) of the official Residence of the Hon'ble Minister for Revenue & Vigilance at Asoka Bunglow and requested for Administrative sanction for the above work.


