As per reference 2nd cited, K.R.Chandra Mohan, 2nd Grade Overseer, N.H. Division Kozhikode has submitted a representation by requesting to include his name in the final Seniority List of 2nd Grade Overseers for the period from 1/8/1985 to 31/3/1990 published vide reference 1st cited. On verification it is understood that the name of the incumbent is not found in the respective Seniority List.

The Executive Engineer N.H. Division Kozhikode has forwarded the Service Book of Sri.Chandra Mohan.K.R vide reference 4th cited in reply to this office letter of even no dated 24/7/2012. As per the Service details, the incumbent entered into Service as 3rd Grade Overseer vide Advice No.RIIA(4)38338/78 GW dated 7/10/79 and the No and date of appointment order is 1539/79 dated 3/12/79 of the Chief Engineer (General) and he was given rank No.1038 in the final Seniority List of 3rd Grade Overseers as on 1/10/81 published vide order No.7/SC/PW/81 dated 28/3/1988. Because of non qualification Sri.Chandra Mohan.K.R was deprived of promotion in the Order No.EC2/6307/79 dated 29/10/84. Later he was promoted as 2nd Grade Overseers vide Order No.EC2/6307/79 dated 27/9/1985 of the Chief Engineer (General), Thiruvananthapuram and joined duty on 19/12/1985 F.N. During the bifurcation of PWD in to PWD and Irrigation Department vide G.O.(MS)38/91/PW & T dated 27/5/1991, he was placed in PWD Optees list as Sl.No.469.Hence he is eligible to find a place in the final Seniority List of 2nd Grade Overseers (PWD Optees) for the period from 1/8/1985 to 31/3/1990 as Rank.No.8(a) in between Sri.Dinesan.M.K (Rank.No.8) and Sri. Radhakrishnan.M.A (Rank.No.9)
