**Procedure/Guidelines for submission, acceptance & award of tenders in respect of various works – Instructions – issued as per G.O.(P)No.06/2012/PWD**  
**Dated:10.1.2012.**

- i. It should be made compulsory that all contractors who procure the tender forms to submit the tender with required EMD. Those who fail to submit tenders consecutively for 3 works will be debarred from participating in the tender for a stipulated period of time ranging from 3 months to 6 months and those who fail to submit the tenders consecutively for 5 works or more must be denied renewal of registration.
- ii. Whenever the tendering authority suspects collusion among contractors in the tender process, the tender will be cancelled.
- iii. There should be a confidential reporting system to assess the performance of contractors in terms of the timely execution of work, quality of work and workmanship. The licensing authority should review the performance of the contractors while renewing the licenses to ensure that only deserving cases are renewed.
