ORDER NO. EC2 /758/2017 DATED: 15/07/2017

As per order read 1st above, Smt.Smitha Das Engineering Assistant and Smt.Boby Varghese Engineering Assistant was temporarily promoted as Assistant Engineer as per rule 31 (a)(i) of the General Rule of KS&SSR 1958 and posted to Electronics Division, Thrissur and Electronics sub Division Kozhikode respectively with specific condition that they will be reverted as and when PSC candidates joins as Assistant Engineer in electronics wing of this department. This temporary promotion of Engineering Assistant as Assistant Engineer would not be regularized before the occurrence of vacancies under promotion quota on any account. They were also not entitled to claim any preferential benefits and their seniority will be determined based on proviso 3rd to Rule 27(a) Part II of KS&SSR. And also they will be on probation for the period of two years of duty within a continuous period of three years service, from the date of regularization of the temporary promotion of Assistant Engineer.

Now two vacancy arised in the cadre of Assistant Engineer (Electronics) with effect from 02.06.2017 and 15.06.2017 due to the promotion of Smt.Binu.P.K Assistant Engineer and Sathyamoorthy.P Assistant Engineer as Assistant Executive Engineer respectively.

In this circumstance the temporary promotion of Smt.Smitha Das in the cadre of Assistant Engineer is regularized with effect from 02.06.2017 and the temporary promotion of Smt.Boby Varghese in the cadre of Assistant Engineer is regularized with effect from 15.06.2017.They will be on probation for a period of 2 years with in a continous period of three years with effect from the date of regularization.
