**ORDER**

As per Government Order read as first paper above along with a few Assistant Executive Engineers Sri. Asokan Vennarakkal, Assistant Executive Engineer, Roads Sub Division, Thalipparamba and Smt.T. J. Mary, Assistant Executive Engineer (Technical Assistant) Roads Division, Kannur were mutually transferred. Aggrieved by this order Sri. Asokan Vennarakkal filed WP (C) No. 979/11 before the Hon'ble High Court of Kerala and vide interim order dt. 11.01.11 the Court stayed the implementation of the transfer order. In compliance with the interim order dt. 11.01.11 in the above WP (C), the transfer of the petitioner was ordered to be kept in abeyance as per Government Order read as 2<sup>nd</sup> paper above.

The High Court of Kerala vide judgment read as 3<sup>rd</sup> paper above dismissed the case as the petitioner sought permission to withdraw the writ petition.

In the circumstances Government are pleased to rescind the Government Order read as second paper above directing to keep in abeyance the mutual transfer of Sri. Asokan Vennarakkal, Assistant Executive Engineer, Roads Sub Division, Thalipparamba and Smt.T. J. Mary, Assistant Executive Engineer (Technical Assistant), Roads Division, Kannur. The Chief Engineer (Admn) shall report to Government the date of joining duty of the incumbents in the new stations urgently.
