ORDER

As per the Government Order read above, Govt had revised the PWD Manual which was implemented w.e.f 01.04.2012.

In the letter read above, the Managing Director, Kerala State Construction Corporation Limited pointed out that as per the sub section (ii) of section 1901 of the revised PWD Manual the Kerala State Construction Corporation Limited have been omitted which caused difficulties challenging its validity of registration as 'A' class contractor and gave rise to series of litigations by way of filing legal proceedings. Hence the Managing Director, Kerala State Construction Corporation Limited has requested to substitute the existing sub section (ii) of Section 1901 as follows:-

"ii. Application of the Rules. These rules will not apply for the Registration of Labour Contract Co-operative Societies, Bharath Sevak Samaj, other worker's bodies and Kerala State Construction Corporation Limited which are governed by separate Government Orders and also in respect of works which are executed under the famine relief and flood relief rules".

The Chief Engineer, KSTP proposed and recommended a substitution for the above rules under Sub subsection 5 of subsection 6 of the Section 1901 in page No.117 of the Revised PWD Manual.
